AGREEMENT

This document entered into this ___ day of _____, 20___, will be Agreement between Kremson Group, Ltd. and a model working from a studio or an individual model. In this Agreement Model working from Studio or Individual Model will be called “Consenting Side”.

This document is made in order for Consenting Side to begin successfully work with Kremson Group, is an entertaining portal connected with video internet conferencing having its own unique customers.

NOW, THEREFORE, in consideration of the mutual promises set forth herein, it is agreed between the parties as follows:

1.a. Kremson Group provides Consenting Side access to web site DivaShow.com allowing Consenting Side to make performances for DivaShow’s customers. Kremson Group does not insist on making any set schedule for Consenting Side for work on the site. Kremson Group, provides Consenting Side access to the web site at any time convenient for her.

b. Consenting Side agrees to broadcast using only IP addresses given by her in the Agreement. In case if Consenting Side wants to broadcast using any other IP address she has to get in touch with Support Service.

c. All financial expenses connected with signing up and starting work with DivaShow.com are on Consenting Side.

2. Consenting Side working with Kremson Group, will receive profits from their work strictly accordingly to the following points. Any other compensations or rewards may be considered between Kremson Group, and Consenting Side by decision of administration of the site.

3. Kremson Group, pays out total model’s earnings said by conditions of the agreement. There are no employer-employee relationship between performer and Kremson Group, Kremson Group, is not responsible for, and will not pay any federal or state taxes of the country from which performer broadcasts, including but not limited to, income withholding taxes, social security taxes, unemployment taxes, or disability taxes. Consenting Side is not entitled to receive any benefits of Kremson Group, besides that part of her income which is according to the agreement.

4. Kremson Group, is not responsible for any kind of moral damage about which Consenting Side can state.

5. There are rules of conduct and work on DivaShow.com. Any violation of the following rules of paragraph 5 cause to immediate termination of the agreement between Kremson Group and Consenting Side. Below are the rules:

- In order to work as a DivaShow model you must be of the full legal age and agree to the following terms.

ATTENTION TO CONSENTING SIDE: if our Company finds any model working under full legal age her login and password will immediately blocked. If the model works from a studio in this case all logins of this studio will be blocked without explanation and payments. We are asking you earnestly not to falsify ID for models.

- Models should only connect to the site using logins they acquired during registration. None except registered models can appear on camera under account.
- Role playing demonstrating underage sex or simply pretending of being underage (except dressing), rape, incest, blood or bestiality is strictly forbidden.
- Violence is strictly forbidden. You may not cut, maim, lacerate or in any other way inflict possible life threatening harm to yourself or another model within the cameras view.
- Child pornography of any sorts is strictly forbidden to be discussed neither in public or private chats.
- Fisting is strictly forbidden (all five fingers penetrate with thumb).
- Bodily fluids including urination/defecation are strictly forbidden on camera.
- Animals within cameras view are strictly forbidden.
- Usage of alcohol/drugs on camera either being in state of alcoholic/drug intoxication is strictly forbidden.
- Models cannot use DivaShow as means to promote any direct physical contact with any DivaShow customer for purposes of prostitution, escorting or related activities.
- No solicitation. Requesting or accepting any offers to get paid outside DivaShow payment methods for the services rendered are not allowed.

- Models cannot make an exchange of any personal information about themselves or another models, including emails, addresses, phone numbers, account numbers, yahoo Ids, MSN Ids, etc.
- Promoting and advertising other web sites or services is strictly forbidden.
- Models cannot ever lie or promise to client anything they will not do in private.
- Models can kick or ban rude visitors from chat room, but do not abuse this feature. Being unable to handle situation with rude visitors, models should contact DivaShow support. Models cannot be rude to clients themselves.
- Nudity is not allowed in free chat with preview.
- Photo gallery should contain only photos of models who are registered under particular account. Photo on profile should be with face and without unconcealed nudity, where models should be clearly seen.
- Models cannot discuss other models or customers both in public or private rooms.
- Models cannot leave the room with camera on. Being busy or going on break, model should set video on break or log off.

6. Consenting Side agrees that she may start work only after her adulthood is verified with her documents.

7. Consenting Side represents that she is an adult and over the age of eighteen years old. As a condition to DivaShow's performance under this Agreement, Consenting Side must first submit proof of her name and age in a form acceptable to Kremson Group. Acceptable "proof of name and age" shall be a copy of passport.

Consenting Side agrees to accept any innovations of Kremson Group connected with new technologies, advertisement, design, representing of materials, photo-, audio-, text production which were ever represented by Consenting Side for Kremson Group. Any photo-video- audio and text production represented by Consenting Side after accepting this Agreement is property of Kremson Group and can be used by company's judgment.

12. Consenting Side represents and warrants that her execution of this Agreement complies with all federal, state or local laws or regulations, and that Consenting Side has obtained all consents, approvals or authorizations necessary to execute and perform under this Agreement.
